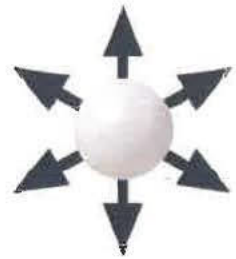

Report Narrative On 3/31/16 at 9:20PM, Corporal Highland #144, Officer Romero #112, Officer Gutierrez #125, Officer Catt #139, and I, Officer Snapp #124, were dispatched to [REDACTED] for a physical domestic. DuComm advised the complainant heard a lot of noise coming from the unit beneath them and believed there were two people fighting.

Upon arrival, we walked to unit [REDACTED] and noticed the lower unit was [REDACTED]. We knocked on the door and a female voice inside asked us to hang on a minute. We could hear her crying through the door.

The female opened the door and she had visible injuries to her face. She invited us in and stated she and her two year old were the only two people in the unit. We searched the unit for any other people and did not find anybody else. During the search of the unit we noticed the master bedroom appeared to be the setting of the confrontation. There was blood in various locations from the bed to the carpet and into the hallway and bathroom.

We called medics to the scene to assess the female, [REDACTED] (76) for her injuries to her face. She had a swollen lip and there was blood coming from her mouth. She was visibly upset and crying. She began to blame herself for what happened.

Warrenville Paramedics arrived on scene and spoke with [REDACTED]. During their evaluation with [REDACTED] she was distraught and stated she should just kill herself. The paramedics continued to evaluate her. They went outside to call the doctor to see if a transport was necessary for her injuries because she had been drinking. The paramedics stated a transport was not necessary. It is unknown if they relayed the suicidal statement to the doctor.

[REDACTED] was not cooperative at all. She did not say who struck her and would not tell us who was at the unit. She stated he was a black male, a doctor and the father of her two year old daughter, [REDACTED]. She was with him for 5 years, but did not want to get him into any trouble because he was married with a family of his own. She mentioned her father was a retired Illinois State Trooper that lives in Plainfield. It was evident that [REDACTED] had been drinking. She had an odor of alcoholic beverage on her breath. [REDACTED] added that she and her now ex-boyfriend had a few bourbon drinks.

We spoke with the complainant, [REDACTED] and [REDACTED]. They stated the following in summary and not verbatim: They heard yelling, crying and felt the wall shake as if someone was thrown against it. They stated it happens monthly, but this is the loudest it has been yet. [REDACTED] saw the suspect leave in a newer model jeep with black rims. He said the suspect was a tall black male.

Due to [REDACTED]'s lack of cooperation by covering up for the offender, her level of injuries and intoxicated state, I sent Plainfield Police to [REDACTED]'s father's home. I requested for him to call me. [REDACTED]'s father, [REDACTED] later called and offered his assistance. He was able to provide a first name and a place of employment for her boyfriend and father of [REDACTED]. He stated the first name was Vernon and middle name was Terry, but he did not know his last name. He added he was a male black and he works at CDH and delivers babies. Vernon has been with [REDACTED] for about 4 years. He is about 6'2" and 210 pounds.

Corporal Highland located a Vernon T. Cannon, M.D. on the Dupage Medical Group website. The website provided a picture of Vernon. The description seemed to match that given. I called [REDACTED] back to ask if Cannon sounded familiar as a last name. He said yes, that was him. I conducted a LEADS soundex of "Vernon T. Cannon". There was a response for a Vernon T. Cannon (04/18/68) out of Arlington Heights. I conducted a LEADS SOS image search of his Illinois Driver's License photo. The photo appeared to be the same person on the Dupage Medical Group website. I attempted to soundex for a possible vehicle for

Vernon. I was unable to find one, but I did find an [REDACTED] which I assumed was his wife. There were no vehicles listed for Vernon or his wife. I assumed the vehicles he had were leased.

I sent Arlington Heights to the address provided from the LEADS response on his license ([REDACTED]). I requested for them to drive by to see if there was a jeep in the driveway with black rims. Arlington Heights stated there was a black Jeep bearing Illinois Registration, [REDACTED]. The LEADS response for the plate showed it was a leased vehicle to Vernon Cannon. I requested Arlington Heights attempt to make contact with Vernon and see if he had any marks/injuries on his hands. Arlington Heights made contact and stated he did have marks on his hands and scratches on his head and neck. They took him into custody and transported him to their police department.

I traveled to the Arlington Heights Police Department and picked up Vernon. I asked if he had an idea as to what it was about and he replied yes. I handcuffed Vernon and searched his person. I double locked his handcuffs to prevent injury to his wrists. I placed him into the back of squad 211 and transported him to the Warrenville Police Department.

I interviewed Vernon in interview room# 2. He stated the following in summary and not verbatim: He worked at the Wheaton Office until 5PM and drove to [REDACTED]'s house in Village Green. He waited for her to get home from work. She arrived at 5:45PM. He, [REDACTED], and [REDACTED] which he added was his daughter, went inside the home. [REDACTED] and Vernon started to drink bourbon in the bedroom. They had an argument because he stated he wanted to be done with the relationship. The argument escalated and [REDACTED] ended up scratching him and biting his finger. Vernon wanted to leave, but [REDACTED] would not let him. Vernon does not remember who started the physical altercation. Vernon added he pushed [REDACTED] in the face to get her away from him then she bit him. The push resulted in [REDACTED] falling onto the floor. Vernon said he did not punch [REDACTED] in the face. He said [REDACTED] was not in the bedroom during the incident. She was in the front room by herself. Vernon has gone to [REDACTED]'s twice a week for the past 5 years. They have had prior incidents before, but they were mostly verbal.

Vernon was fingerprinted and photographed. He was charged with two misdemeanor counts of domestic battery and provided his copy of the misdemeanor complaint. He was also provided his copy of the verification (#3520169217016). I completed the domestic violence supplemental report.

Officer Catt took photos of the scene, [REDACTED] and Vernon. The photos were placed onto disks.

Both parties were provided domestic violence information sheets.

I called family shelter services and spoke with Grace about the incident.

I called DCFS and notified them of the incident. I spoke with Michelle Paisley and she provided me with an intake # of 13187417.

The two CDs containing photographs and the CD containing the interview with Vernon were placed into evidence locker #3.

I have nothing further.



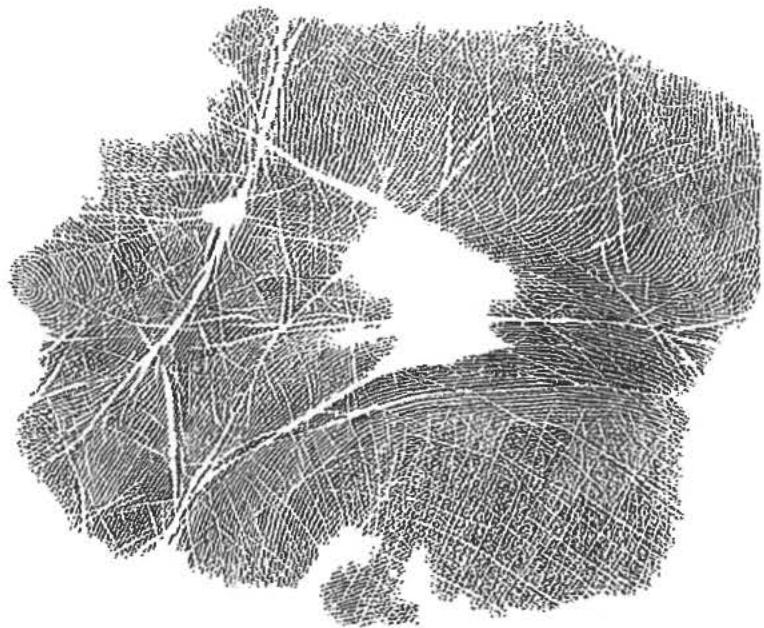
